You are about to purchase a product that is not simple and may be difficult to understand.

# 1. What is this product?

#### Type

An Over the Counter (OTC) derivative contract – FX Knock-In Forward (American-style)

#### Objectives

FX Knock-In Forward (American-style) products are used for managing foreign currency risks.

An FX Knock-In Forward (American-style) is an agreement between two contracting parties (client/UniCredit Bank S.A.) to exchange an agreed amount of one currency for another currency at an agreed fixed rate on an agreed future date.

In an FX Knock-In Forward (American-style), you acquire the right but not the obligation to sell an amount of a specific currency (e.g. RON notional amount) and buy an amount of another currency (e.g. EUR notional amount) at an agreed fixed rate (strike rate) on an agreed future date (settlement date). You may exercise your right on an agreed date (expiry date).

At the same time, your right to sell becomes an obligation if the spot rate (i.e. the price of the currency pair on the spot market) has been trading at or below the knock-in rate anytime from the trade inception until the expiry of the option.

In addition, you might agree to pay a premium to the bank; in any case, you will not get back the premium you paid.

Sample product terms are set out below and are based on legally predefined or realistic assumptions and may not match your specific contract details, e.g. your specific notional amount, whether or not you will pay a premium, etc.

# 2. What are the risks and what could I get in return?

#### Risk Indicator

# 3. What happens if UniCredit Bank S.A. is unable to pay out?

#### 4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself for the recommended holding period. The figures assume a notional amount of EUR 10,000. The figures are estimates and may change in the future.

# Recommended holding period: 1 Year
