## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

## 1. What is this product?

### Type

An Over the Counter (OTC) derivative contract – Commodity Collar (buy call option and sell put option)

### Objectives

Commodity Collars are used for managing commodity price risks.

A Commodity Collar (buy call option and sell put option) is an agreement between two contracting parties (client/UniCredit Bank S.A.), where you buy a call option and sell a put option at the same time. If the floating price of the underlying commodity exceeds the strike price of the call option on a fixing date during the contractually agreed term, you receive a compensation payment for the respective calculation period, which is calculated as the difference between the floating price and the strike price of the call option, based on the notional quantity for the respective calculation period. If the floating price of the underlying commodity is below the strike price of the put option on a fixing date during the contractually agreed term, you pay a compensation payment for the respective calculation period, which is calculated as the difference between the strike price of the put option and the floating price, based on the notional quantity for the respective calculation period. The floating price can be determined as the reference price on the fixing dates or calculated as average of the reference prices for the respective calculation period.

When entering into a Commodity Collar (buy call option and sell put option) you may pay or receive an option premium depending on the agreed strike prices. In case you pay an option premium, the option premium is non-refundable. The amount of the option premium depends among other things on the term of the options, the level of the strike prices of the call option and the put option and the volatility of the reference price.

The notional quantity of the Commodity Collar (buy call option and sell put option) serves merely to calculate the respective payments. There is no physical delivery of the commodity underlying.

You can enter into this product also in a foreign currency.

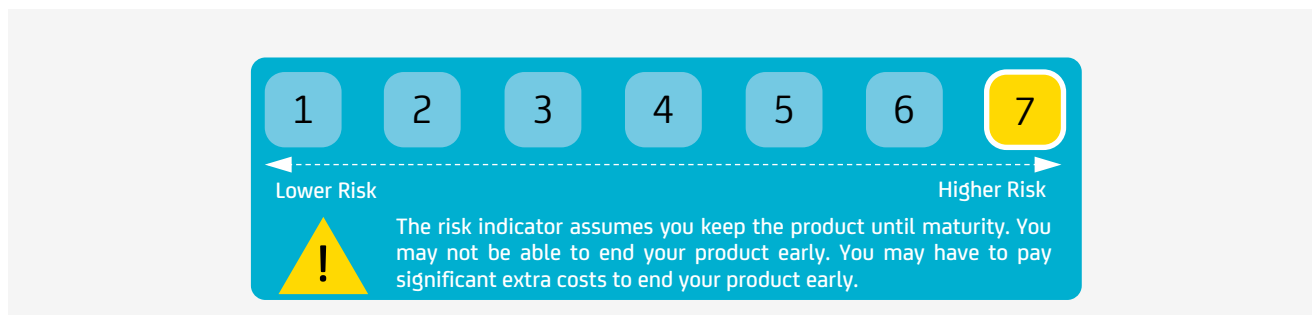

## 2. What are the risks and what could I get in return?

### Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.



Be aware of currency risk. You may pay and/or receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

## 3. What happens if UniCredit Bank S.A. is unable to pay out?

Counterparties of derivative transactions are exposed to the risk that UniCredit Bank S.A. becomes unable to discharge its obligations under the transaction, for example in the case of an insolvency (inability to pay or overindebtedness) or in the case resolution measures are taken by an authority against the credit institution. Such a decision to take resolution measures can, for example, be taken if the assets of the institution are less than its liabilities, where it is unable or will, in the near future, be unable to pay its debts or other liabilities as they fall due, or where it requires extraordinary public financial support. Where resolution measures are taken, the competent resolution authority can decide on an early termination of the derivative transaction. In the case such early termination results in a claim of the counterparty against the credit institution, the decision of the resolution authority can lead to a partial or complete reduction of the principal amount of this claim or in a conversion of this claim in to equity (shares or other types of equity).

If UniCredit Bank S.A. does not fulfil its obligations connected with the product or is unable to pay, you can lose part of or the full payout or can suffer an unlimited loss. This product is not protected by any deposit guarantee scheme, legal or otherwise, or any other type of guarantee.

#### 4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself for the recommended holding period. The figures assume a notional quantity of 12 metric tons. The figures are estimates and may change in the future.

#### 5. How long should I hold it and can I take money out early?

Recommended holding period: 1 Year

The recommended holding period is equal to the contractually agreed term. You are not entitled to terminate the product unilaterally before the end of the contractually agreed term. This does not apply in case you have contractually agreed with UniCredit Bank S.A. that one party or both parties have the right to prematurely terminate this product upon notice to the other party and subject to a compensation payment (contractual early termination clause).
